Subject: NOTICE OF EMERGENCY TELEPHONE CHARGE INCREASE

To who it may concern:

Summary

The Jefferson County Emergency Communications Authority (“JCECA”) has raised the emergency telephone charge to two dollars and five cents (\$2.05) per access line per month in its service area effective on February 1, 2024. Remittance information is set forth at the end of this letter.

Increase in the Emergency Telephone Charge

JCECA has the authority to raise the emergency telephone charge pursuant to C.R.S. § 29-11-102(2)(a). On November 30, 2023, the Board of JCECA voted to increase the emergency telephone charge in JCECA’s service area from one dollar and thirty cents (\$1.30) to two dollars and five cents (\$2.05).

Affected Area: JCECA’s Service Area

JCECA’s service area is on the western side of the Denver, Colorado metropolitan area and includes the following counties and municipalities:

- Jefferson County, Colorado
 - *Please note that the City of Littleton is partially in Jefferson County and partially in Arapahoe County. The Arapahoe County Emergency Communications Service Authority sets and collects the emergency telephone charge for all of Littleton, including those portions of Littleton in Jefferson County.*
- Broomfield, Colorado
- The following cities in their entirety, which are located in Jefferson County unless otherwise noted:
 - the City of Arvada, which is located in Jefferson and Adams Counties**
 - the City of Broomfield, which is located in Broomfield County
 - the City of Edgewater
 - the City of Golden
 - the City of Lakewood
 - the City of Westminster, which is located in Jefferson and Adams Counties**
 - the City of Wheat Ridge

*** All of Arvada and Westminster are in JCECA’s service area, including those portions in Adams County.*

- The following towns in their entirety, all of which are located in Jefferson County:

 - Lakeside
 - Morrison
 - Mountain View
- The following census-designated places, all of which are located in Jefferson County:
 - Applewood
 - Aspen Park
 - Columbine
 - East Pleasant View

 - Kittredge
 - West Pleasant View
- The following unincorporated communities, all of which are located in Jefferson County:
 - Buffalo Creek
 - Conifer
 - Pine
 - Pine Junction

Effective Date

The effective date of the increase in the emergency telephone charge is February 1, 2023. Beginning on February 1, 2023, please increase the emergency telephone charge in JCECA’s service area to two dollars and five cents (\$2.05).
